

# preservation initiatives grant

#### **MISSION STATEMENT**

The Preservation Initiatives (PI) Grant Program provides matching grants to individuals and non-profit organizations for preservation planning, research, outreach/education, and bricks and mortar projects related to historic and cultural sites. These grants are intended to help stimulate public discussion, introduce the public to preservation concepts and techniques, make technical expertise accessible, and encourage partnerships.

#### **GRANT CYCLE & DEADLINES (2023)**

Awarded projects must be completed within one year of signing the grant agreement.\*

- December 1, 2022: Application opens
- March 1, 2023: Application closes NO EXCEPTIONS

After the application closes, the review process begins. All grantees will subsequently be notified of whether or not they are receiving a 2023 PI Grant. Successful grantees will then sign a grant agreement.

\*Bricks & Mortar projects are allowed up to two years for completion.

## PRESERVATION INITIATIVES FUND: VIRGINIA AVENUE TUNNEL

Administered by DCPL, in consultation with the DC State Historic Preservation Office (DC SHPO)

#### GOAL

The goal of the fund is to distribute funds within the geographic area surrounding the Virginia Avenue Tunnel Reconstruction Project that will be used to preserve, restore, research, identify and evaluate, interpret or otherwise benefit historic resources within the project area.

#### SOURCE

Funds for the Virginia Avenue Tunnel Grant Project were provided by CSX Transportation Inc., and through the DC Historic Preservation Office as mitigation for adverse effects associated with reconstruction of the historic tunnel in accordance with Section 106 of the National Historic Preservation Act.

Develop strategies for the preservation of a historic site.

\$5,000-\$10,000 25% Match Required



Support for research efforts of a historic property/site.

\$5,000-\$10,000 25% Match Required





Programs or educational material related to historic sites that actively engage & educate the public.

\$5,000-\$10,000 25% Match Required

Work that physically preserves a historic property (must be a designated historic landmark).

\$10,000-\$50,000 100% Match Required

- 3. Mail (1) printed application packet to DCPL\*



# preservation initiatives grant VIRGINIA AVENUE TUNNEL FUND



### BASIC REQUIREMENTS (ELIGIBLE PROJECTS MUST BE):

- Located within the Area of Potential Effect (see map above);
- Involve properties which are listed in the National Register of Historic Places and/or the DC Inventory of Historic Sites, or determined eligible for listing in the National Register/DC Inventory by the DC SHPO;
- "Historic preservation-related";
- Comply with The Secretary of Interior's Standards for the Treatment of Historic Properties, as applicable;
- Involve "bricks and mortar" work, survey, evaluation, historical research, archaeological investigations, public outreach, interpretation or other closely related topics.
