#### Remembering Hayden Wetzel (1950-2023)



For more than 20 years, Hayden Wetzel (1950-2023) was an enthusiastic and energetic member of the DCPL Landmarks Committee. He made key contributions in many areas, but he particularly enjoyed mentoring volunteers in mastering the intricacies of preservation research. Hayden generously shared his knowledge of Washington's many specialized collections and archives, but, as he once remarked, the streets themselves were perhaps his favorite libraries. His block-by-block explorations on foot brought a very diverse set of buildings from across the city to the committee's attention and ultimately to the DC Inventory of Historic Sites and National Register of Historic Places. Successful landmark nominations he authored or co-authored include <u>Chapman Coal Company Stable and Garage</u>, PEPCO's <u>Buzzard Point Power Plant</u>, <u>St.</u> Paul's College, and, most recently, the Schlitz Brewing Company Washington Branch/National Geographic Society Warehouse. Hayden's successful nominations for the original <u>DC Pound and Stable</u> and <u>Washington Animal Rescue League Shelter</u> and Hospital provided a foundation for Mangy Curs and Stoned Horses, his history of local animal control published in 2019. Hayden was passionate about DC's built environment, as illustrated by his many landmark nominations and this 2022 article in the Washingtonian about his efforts to save two Quonset huts in Brookland His unique perspective and imaginative spirit will be deeply missed by his many friends on the committee.

Last month, DCPL submitted a landmark nomination for **Rosemount Center (formerly** 


known as the House of Mercy), which is located on a wooded lot above the Rock Creek Valley in the Mount Pleasant Historic District. Designed in a Mission/Spanish Colonial Revival style by Nathan C. Wyeth, it was the home of the House of Mercy from 1911 until 1972, when it became the Rosemount Center. The property has long provided social services and is both historically and architecturally significant.


